### 2. Submission Risks:

The filmmaker(s) acknowledge the risks associated with submitting their films online, including but not limited to piracy and unauthorized distribution through screen recording or other methods. RIF is not liable for any such occurrences.

### 3. Project Document Accessibility:

The filmmaker(s) agree that the project documents submitted may be accessible to third-party partners, evaluation committees, and consultants associated with RIF 2024.

### 4. Promotional Use of Materials:

The filmmaker(s) grant RIF the right to use film stills, posters, and trailers submitted for promotional purposes across RIF's social media and marketing channels.

### 5. Electronic Communication Risks:

The filmmaker(s) acknowledge and accept the risks associated with electronic communication, including the possibility of emails being lost, intercepted, or altered by outside parties. RIF shall not be held responsible for any damages resulting from such occurrences.

### 6. Responsibility for Submissions:

RIF shall not be held responsible for submissions that are lost, stolen, or damaged during transit. The filmmaker(s) agree to send all required materials in advance to ensure smooth screening operations.
